The Metro Colombo Solid Waste Management Project is established under the Ministry of Urban Development & Housing which is implemented with the objective of providing a long term sustainable solid waste management system that is socially acceptable environmentally friendly and economically feasible for Metro Colombo Region and other potential Local Authorities. The Project is comprised of four components which the GoSL has already been developed. (i) Transfer Stations at Kelaniya and Aruwakkalu, (ii) Sanitary Landfill at Aruwakkalu, (iii) Rail Track Extension and Connectivity Line, (iv) Rail equipment, Machinery and other improvements. The bidder is required to operate & maintain all the above four components together with his necessary investment for the proposed technology; which is to be Design, Build, Finance, Operate and Maintain under BOOT (Build, Own, Operate and Transfer) modality.
