Rationale

Thailand is the largest economy in mainland Southeast Asia and the second largest in ASEAN. With its strategic location at the heart of Southeast Asia, a well-developed transportation infrastructure—including modern highways, an inclusive rail network, ports, and airports, a sizeable and expanding consumer base and a highly skilled labour force, Thailand has emerged as a preferred destination for international investors. Furthermore, Thailand has the largest number of students studying the Korean language globally, ensuring a skilled workforce ready to support Korean enterprises operating in the country.

The Royal Thai Embassy prioritises the advancement of the economic partnership between Thailand and the Republic of Korea (ROK). We are fully committed to transforming untapped both countries' economic partnership potential, which is still relatively modest considering the ROK's immense advancement, into tangible outcomes. As such, the Royal Thai Embassy has initiated a series of activities, including, most recently, the **Industrial Estate Authority of Thailand (I-EA-T) Business Seminar: Exploring Partnerships and Opportunities** on 9 September 2024 and the **Investment Mission: Korean Investment Opportunities in Thailand** on 15-19 December 2024.

The organisation of IGNITE Thailand-Korea Business Forum is part of a broader effort to foster bilateral investment and trade between the two countries while maintaining momentum of regular communication by providing a platform for Thai and Korean businesses to connect and collaborate effectively.

Objectives

- 1. To provide an overview of Thailand's economy and business potential.
- 2. To introduce investment opportunities in Thailand and investment incentives to support foreign investors.
- 3. To establish a platform for Thai and Korean businesses and networks between businesses, business associations, and relevant government agencies from both countries.

Format

The two-day event will feature a diverse lineup of sessions, including in-depth keynote presentations, panel discussions, and networking opportunities centered around three key themes: (1) Investment and Ease of Doing Business in Thailand, (2) Thailand's Banking and Stock Market, and (3) Industrial Estates and Real Estate Development in Thailand. Participants will include Korean businesses, business associations, and relevant authorities, as well as Thai investment-related agencies, private sector representatives, and business associations.
